NYSEA CAMPING RULES

Camping is available only to those who are members of the NYSEA. If you are unable to provide proof of membership will be asked to purchase a membership prior to being allowed to park their camper on the grounds. Our primary objective is the safety of our participants and spectators while providing education and reminiscing about days past. Anyone that does not comply with the camping rules may be asked to leave NYSEA grounds.

- 1. Camper parking will take place between 7:00am 7:00pm. If you arrive early or late please park in the North parking lot (general parking) until the camping office shed is open. Do not park on the road.
- 2. Every vehicle parked inside the gate must display a pass issued by the camping shed. Exhibitors must have a current membership to obtain a pass. Passengers not under 16 are not covered by a family membership and are subject to the general admission charge.
- 3. During normal show hours (8:00am 8:00pm), please keep motorized traffic to a minimum to reduce congestion and keep everyone safe. Use the perimeter driveways if movement is necessary. ABSOLUTELY no cars on main street or in the flea market during show hours.
- 4. NO GAS, PROPANE TANKS OR ANY FLAMMABLE MATERIALS CAN BE UNDER CAMPER. MUST BE 10FT FROM CAMPER AND AWNING. IF USING A GENERATOR, IT MUST HAVE A FIRE EXTINGUISHER WITHIN 10FT.
- 5. All campers need to be 10ft from each other. No touching of awnings with your neighbors.
- 6.. ALL DISCHARGE OPENINGS MUST BE CAPPED AT ALL TIMES. ABSOLUTELY NO DUMPING OF GREY OR BLACK WATER ON THE GROUND. MOBILE DUMPING IS AVAILABLE DAILY. LET THE CAMPING SHED KNOW IF YOU NEED THIS SERVICE.
- 7. ONE vehicle is allowed per campsite. Extra vehicles must park in the general parking lot.
- 8. No exhibiting in the general camping sites. Violators will not be able to have that site again in the following years.
- 9. If electric is available at your site, it is to be used ONLY for lighting. Use of air conditions or other large electrical devices is not permitted.
- 10. All campfires need to be contained. Must be at least 10 ft from the nearest camper or awning and at least 5 ft from site boundary. Please do not leave plastic or metal residue in the fire pit.
- 11. Quiet hours in the camping areas are between 10:00pm and 7:00am. Please be courteous to your neighbors. If you have a medical necessity to run a generator at night, let the camping staff know so you can be put in an area that won't disturb others.

- 12. Golf carts and personal transport vehicles are permitted. The vehicle must be insured, proof must be available upon request.
- 13. TO OPERATE ANY MOTORIZED EQUIPMENT, YOU MUST BE 16 YEARS OLD WITH A DRIVERS LICENSE. THIS INCLUDES LAWN MOWERS AND GOLF CARTS.
- 14. Dogs must always be on a leash and not be left unattended. Please clean up after your pet. Vaccination records must be available upon request.
- 15. Children must be at their site after 10:00pm unless accompanied by an adult
- 16. Bicycle riding on the show grounds is not permitted at any time.
- 17. New York State law prohibits the use of fireworks of any kind. Anyone using fireworks on the NYSEA grounds will be required to leave.
- 18. Public use of alcohol is prohibited.
- 19. NYSEA is not responsible for stolen, lost, soiled, damaged clothing or property.
